In 2011, LISC hosted its first Neighborhoods Matter: Community Development Symposium bringing together civic leaders to discuss the future of Milwaukee. At the symposium, LISC unveiled a commissioned study on Milwaukee’s community development landscape.

LISC supports five Sustainable Communities. This year, LISC celebrated the Harambee neighborhood’s accomplishments: improving housing, creating jobs, sparking business, reducing crime, and accessing healthy food. Washington Park and Layton Boulevard, launched new Neighborhood Action Plans. In partnership with the Zilber Neighborhood Initiative, LISC supported capacity-building in Clarke Square, Lindsay Heights, and Layton Boulevard neighborhoods.

LISC’s Milwaukee Awards for Neighborhood Development Innovation (MANDI) recognized 16 inspiring stories of people and projects improving the central city.

LISC released its new strategic plan focused on “going deep” into the areas of real estate development, commercial corridor revitalization, community safety, and capacity building.
