
HIGHLIGHTS OF 2016





2016 was a busy year for LISC DC. We received an award. We published a report. We went to the White House. We toured select housing preservation projects with our Local Advisory Committee. We launched a targeted initiative focused on fostering equity, inclusiveness, and an improved quality of life for low-income households near the site of a forthcoming multimillion dollar development. We participated in several ribbon cuttings and ground breakings for newly renovated properties and projects that will bring more amenities to DC residents. We were panelists and moderators for various events. We were quoted and interviewed for several publications. We invested over \$45 million into over 1,200 units of affordable housing for low-income and special needs households. Preservation Works: LISC DC's Role in Preserving Quality

THE BUCHANAN



LISC DC provided a \$1.6 million loan to MED Developers to acquire, stabilize and upgrade 4526 13th Street, NW. Our investment enabled the building, known as The Buchanan, to maintain its affordability, as well as undergo much needed renovations, repairs, and upgrades. One of the residents of The Buchanan, 107 year old Mrs. McLaurin, became famous when video footage of her dancing with the Obamas went viral last year.

After completion, it will have on-going property management and maintenance support. The Buchanan is a 16 unit apartment building located in the Petworth neighborhood, one of the most rapidly gentrifying communities in the region where a growing number of apartment buildings are being converted to high priced housing, leaving long-term residents few decent options that they can afford.


LISC DC loaned Sarah's Circle \$550,000 for predevelopment for the renovation of their existing senior housing property located at 2551 17th Street NW in the Adams Morgan neighborhood.

For over 32 years, Sarah's Circle has been serving very low income senior citizens. In addition to undertaking a thorough modernization, Sarah's Circle will reconfigure the 34 unit building into 49 units, providing housing for an additional 15 seniors.


It is a notable opportunity to add affordable units in one of DC's most convenient, and yet expensive neighborhoods.

5741 COLORADO COOPERATIVE

On June 25, 2016, we celebrated the opening of the 5741 Colorado Avenue Cooperative's newly renovated building. Located in the Brightwood-16th Street Heights neighborhood, the 5741 Colorado Avenue Cooperative is home to residents that vehemently sought to preserve their 28 unit building and its infrastructure, while maintaining its affordability.

The ribbon cutting was attended by nonprofit partners, community leaders, and government officials and was a celebration of the residents' steadfastness, tenacity and perseverance.

After years of living in decrepit conditions and fighting to get their basic needs met, the 5741 Colorado Avenue residents collectively decided they were going to take control of their home.

Creative placemaking has the power to boost the health of neighborhoods by investing in the physical and social assets of a community. These investments are particularly important for communities with a history of neglect, blight, disinvestment, and disengagement. This is true for our most recent creative placemaking initiative, which took place in the lvy City neighborhood.

"Ivy City Is..." was a collaborative, resident and artist-led creative placemaking project that culminated in the creation of a three-dimensional, 5 foot by 20 foot screen printed plywood installation, spelling out "IVY CITY." ELEVATING EQUITY LAUNCH



On May 11, 2016, we launched our \$50 million Elevating Equity Initiative in Washington, DC's Anacostia neighborhood! Elevating Equity is our commitment to provide resources that help long-term residents and newcomers – regardless of their income – live, work, and thrive in the neighborhoods adjacent to the future 11th Street Bridge Park.

The 11th Street Bridge Park will be a new venue for healthy recreation, environmental education, and the arts.

We will use our resources to provide loans, grants, tax credit equity, in-kind services, and technical support to our nonprofit partners. These investments will go towards ensuring that residents have access to housing that is affordable and essentials such as medical care, arts, services for youth and seniors, and early learning centers.

A few months ago, instead of taking the morning bus to LISC's office in downtown DC, I headed to the White House for South By South Lawn (SXSL), a day-long festival hosted by President Obama that brought together people from across the world who work for social change. Inspired by the format and vibe of SXSW, the Austin, TX music and culture festival, SXSL was filled with panel discussions about technology, sustainability, and social justice, as well as musical and artistic performances. There was even a conversation between President Obama and Leonardo DiCaprio

on climate change. One of the most powerful moments of the day came just after the funk band Dap-Kings finished their set and Common, the rapper and author, grabbed the mic and spoke from his heart about racial injustice and mass incarceration. He ended his speech with five simple but potent words: "Use your platform for change."
