Combining LISC's financing and community-building abilities with the unique data, knowledge and other resources of health care entities is a priority in this work.

The Position:

This position is based in one of LISC's office in New York City, Washington DC or Chicago IL.

Responsibilities

LISC is seeking a senior leader responsible for stewarding high profile partnerships with health care entities. Responsibilities include:

- Manage major health care partnerships to ensure successful field implementation, timely planning for future collaborations, stewardship of key relationships and ongoing documentation and dissemination of lessons. Includes serving as project manager and coordinator across LISC units involved in various aspects of a select group of major health care partnerships.

- Support research and evaluation efforts tied to priority health care partnerships, including liaising with health system research teams, identifying new opportunities for analysis/evaluation of our work with health care, assembling resources to pursue evaluation goals and encouraging synergy across health care research efforts as appropriate
- Manage a national communications strategy to amplify LISC's work around health, informed by the priorities of our major partners in health care and philanthropy. Includes representing LISC at major conferences and events and coordinating presentations by other LISC senior leaders (with health care executives as appropriate); managing production of content for the LISC website and external publications; and collaborating with the Communications team and health care partners on external media and PR strategies.
- Support policy efforts relevant to priority health care partnerships, including coordinating with the Policy team to staff LISC's participation in key coalitions supported by our major health care partners
- Staff any fundraising efforts undertaken in collaboration with health care partners to support collective programmatic or research goals
- Organize knowledge-sharing meetings across LISC offices and among health care enterprises about successful partnership models

Qualifications

- Bachelor's Degree from an accredited college or university is required. Advanced degree in related field preferred.
- Minimum of 7 years work experience in health care or community development.
- Experience working with health care leaders, in healthcare research and analyzing industry trends.
- Experience developing and managing budgets. Strong project and evaluation management experience.
- Exceptional oral and written communication skills. Proficient in Microsoft office.
- National travel is required (*estimate: 1-2 trips per month*) to conferences, meetings and site visits.
