Human Resources Development Council of District IX	Bozeman, MT	Support the development of over 40 homes, with a mix of affordable rentals and Community Land Trust ownership opportunities.
HOPE Inc.	Wytheville, VA	Organize community meetings to address homelessness and housing. Develop three green certified multi-family developments focused on low-income and critical need populations.
GROW South Dakota	Sisseton, SD	Increase capacity to complete 125 home improvement projects, provide education to 30 individuals, and construct two homes in the coming year.
Greater Greenville	Greenville, MS	Develop three low-income residential units within the Central Business District, using energy efficient materials and appliances.
LIFE	Lufkin, TX	Support the construction of a single-family home and a registered apprenticeship program for carpenters who will assist in the construction of this home.

Self-Help Enterprises	Visalia, CA	Support the Housing Rehabilitation Program in providing resources that address health and safety improvements and assisting with energy efficient and climate resilient upgrades.
OPAL Community Land Trust	Eastsound, WA	Construct 20 new rental residences for households below 50% AMI, with a focus on providing permanent supportive housing for formerly homeless individuals.
NeighborWorks Umpqua	Roseburg, OR	Preserve and improve climate resilience of 31 units of affordable housing by installing ductless heat pumps.
South East Alabama Self- Help Association	Tuskegee, AL	Replace outdated and inefficient A/C systems in 5 units of a 24- unit affordable rental property recently converted to a RAD property.
North Florida Educational Development Corp,	Gretna, FL	Assess housing conditions to renovate a historic warehouse into a mixed-use, energy efficient multi-family building.
Prairieland Community Development	Havana, IL	Complete a Physical Needs Assessment to apply for HUD's Green and Resilient Retrofit Program, ultimately supporting the rehabilitation of 94 affordable housing units.
Tunica County Community Development Coalition	Tunica, MS	Support the development of 12 single-family homes, following healthy housing principles, using the Mutual Self-Help Housing program.
North East Community Action Corporation (NECAC)	Bowling Green, MO	Ensure that homes meet NECAC's Steps to a Healthier Home benchmark through home assessments, household education, and physical improvements to home.
Fayette County Community Action Agency	Uniontown, PA	Implement programming focused on mental health, access to services, and improved tenancy for formerly homeless individuals.
