Col. Mary E. Garr (Ret.) President/CEO, Family Service



Since 1903, Family Service has provided a broad array of services to empower individuals, transform families, and strengthen the health of communities by addressing the social determinants of health that directly impact peoples' lives based on where they live, learn, work, play, and age. Specifically, she and her team work upstream to prevent or mitigate life, community, and systemic effects that affect peoples' long term health and life potential.

An experienced leader with three decades of diverse roles in several industries, including healthcare, city management, nonprofits, and the military as a CEO and COO, including as the last Garrison Commander of Fort Sam Houston and Camp Bullis. She led her teams in providing all the infrastructure and support services for a small city, supporting mission readiness and quality of life, while merging the Garrison into Joint Base San Antonio, and then standing up the San Antonio Military Health System as its first Chief Operating Officer, integrating and aligning Army and Air Force healthcare delivery in San Antonio.

Over the course of her military career, she served in a variety of command and staff positions both in the United States and overseas, in hospital, academic, and operational assignments. Mary Garr graduated from Georgetown University with a degree in Foreign Studies and obtained Master's degrees in Health Administration from Baylor University and Strategic Studies from the U.S. Army War College.

Katie Vela Executive Director, South Alamo Regional Alliance for the Homeless



The South Alamo Regional Alliance for the Homeless (SARAH) is a nonprofit organization and the Homelessness Continuum of Care (CoC) Lead Agency for San Antonio/Bexar County. SARAH works to strengthen coordination, collect and analyze data, and align funding to improve San Antonio's homeless response system, ensuring everyone has a place to call home. Under Katie's leadership, SARAH received statewide recognition in 2021 as Texas Homeless Network's "Organization of the Year" and led, in collaboration with partners, San Antonio's "House America" initiative to successfully rehouse 1,500 people experiencing homelessness in less than one year.

Katie Co-Chairs the Alumni Leadership Circle for UTSA's College of Health, Community, and Policy program and the Trauma-Informed Care Workgroup for Homelessness and Housing. She is a member of the San Antonio Nonprofit Council Advocacy Committee, and served as the mayor's appointment to Co-Chair San Antonio's first Housing Citizen Bond Committee. She is part of Leadership San Antonio Class 47 and was awarded the distinction of "40 under 40" by the San Antonio Business Journal in 2023.

Katie is known for her technical expertise and collaborative approach toward meaningful change while working across complex systems. A native San Antonian, Katie holds a master's degree in Public Administration from the University of Texas-San Antonio with a Nonprofit Administration and Leadership Certificate. 4

Pedro (Pete) Alanis has served as Executive Director for the **San Antonio Housing Trust Foundation** since September of 2019. He brings over 20 years of community development and housing policy experience including serving the City of San Antonio as *Real Estate Administrator* focusing on complex development transactions within our city's urban core and as *Grant Manager* overseeing the city's use of federal entitlement funding.

Through his leadership, Pete was instrumental in completing a structural realignment of the San Antonio Housing Trust's governance structure, implementing a new five-year strategic plan, and aligning efforts with the City of San Antonio's Strategic Housing Implementation Plan (SHIP). In 2021, his leadership earned the San Antonio Housing Trust the inaugural Susan R. Sheeran Bridge Builder Award. Pete currently serves as a San Antonio Housing Commissioner, serves as Co-Chair of the Removing Barriers to Affordable Housing Committee, serves on the Preston Hollow Capital Community CDFI Advisory Board, and is active with the Successfully Aging and Living in San Antonio (SALSA) Initiative which provides housing policy solutions to our older adult and disability community.

Key Functions of the CoC

- Facilitate Funding Process for approximately \$14 Million in HUD CoC Program Annually
- Federal & Community Reports on Homelessness
- Homelink, our local Coordinated Entry System
- Technical Assistance & Coordination with 50+ Partner Agencies
- Programs to Support Homeless Service Providers
- Facilitate Community Workgroups & Set Standards to Improve our Homeless Response System



Development of SARAH

- 2015: Started 2 staff, recruited board (Focused on "CoC" role)
- 2018: Formed Youth Action Board (YAB) to apply for YHDP
- 2019: COSA began developing Homeless Strategic Plan
- 2020: Emerging community priorities & need for planning
- 2021: Developed Compass/Strategic Plan
- 2022: Formed Lived Expertise Advisory Board (LEAB)
- 2023: New rhythms to separate CoC role & Community Priorities



Youth Action Board (YAB)

The mission of the Youth Action Board is to advise and inform on the Youth Homelessness Demonstration Program (YHDP) planning process to represent the youth homeless community in San Antonio. The Youth Action Board is responsible for understanding and advising on improvements for the current homeless system.

2022/2023 Goals:

- Rebuild Community Presence
- Focus on work that destigmatizes
 homelessness
- Recruit 3 new YAB members

Requirements:

- Members must be 17 to 25 years old
- Prospective members are subject to approval by the Youth Action Board
- The Youth Action Board must comprise at least 2/3 active members with lived experience of homelessness.



Lived Expertise Advisory Board (:EAB)

The Lived Expertise Advisory Board (LEAB) aims to advise and inform the TX-500 Continuum of Care by representing the homeless community in San Antonio. The LEAB is responsible for understanding and advising on improvements for the current homeless response system for adults and families. The committee members aim to create a dignified and equitable homeless response system for our community members who are at-risk of or experiencing homelessness.

2023 Goals:

- Create a Self-Care Movement
- Attend Events/Build a Presence in the Community
- Provide Feedback on Policy and Unsheltered NOFO to the CoC

Eligibility:

- Must be approved by the majority through the Lived Expertise Advisory Board officers.
- The LEAB must comprise at least $\frac{2}{3}$ active members with lived experience or housing insecurity.
- To be eligible to vote, the member must have lived expertise.
- Must reside or commute regularly in San Antonio/Bexar County region.

Benefits of Joining YAB/LEAB

- Compensated \$40 per meeting
- Food provided
- Transportation assistance
- Emergency Fund
- Professional Development Opportunities


