We raise funds from banks, corporations, foundations and government agencies. Through our local offices and rural program in 44 states, we work with a vast network of community-based partner organizations to make investments in housing, businesses, jobs, education, safety and health.

How we use our resources

We provide loans, equity, grants and technical assistance to organizations leading projects and programs that help their communities.

Loans

We finance a wide variety of projects including affordable housing, supermarkets, schools, health centers and other vital community projects.

Equity

We invest in housing, retail and commercial centers and arts/cultural buildings, like theaters.

Grants

We fund program-specific efforts, operations and capacity building based on local office strategies and local community needs.

Technical Assistance

We work directly with local community groups to leverage funding opportunities, navigate complex regulations, and develop comprehensive strategies.

LISC is in more places than any other community development organization. We have staff, expertise and relationships in offices nationwide.

LISC engages local leaders and neighbors to plan, set goals and measure progress. We bring local issues to state and national policy leaders.

LISC invests in distressed neighborhoods for maximum impact. Every dollar we invest attracts another \$3 in private capital.

Our communities are better places to live, more people have jobs and incomes rise.


